RESOLUTION NO. 09112023 - #1 DESIGNATING THE IMPROVEMENT OF PLEASANT DRIVE AND CREATION OF RELATED SPECIAL ASSESSMENT DISTRICT

WHEREAS, under the provisions of Act 188 of the Public Acts of the State of Michigan of 1954, as amended, MCL 41.721, et. seq. ("PA 188") the Township Board (the "Board") of the Township of Billings, Gladwin County, Michigan (the "Township"), has the power to make the public improvement of the construction, improvement and maintenance of roads within the Township and to determine that the whole or any part of the cost of the improvement shall be defrayed by special assessment against the property especially benefitted by the improvement; and

WHEREAS, the Board has received a petition for the construction, improvement and maintenance of Pleasant Drive, as described in Exhibit A hereto (the "Project") from record owners of land constituting more than 50% of the total land area in the special assessment district described herein to pay the cost of said improvement (the "Petition"); and

WHEREAS, the Petitioners have obtained and submitted to the Township preliminary plans describing the Project and its location in the Township (the "Plans"), as well a preliminary estimate of the cost of the Project (the "Cost Estimate") as set forth within Exhibit A hereto; and

WHEREAS, after reviewing the Petition, Plans and the Cost Estimate, the Board desires to tentatively declare its intention to make the improvement and to tentatively

designate the special assessment district against which the cost of the improvement is to be assessed, as authorized by PA 188.

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The Petition is accepted and ordered filed with the Township Clerk.
- 2. The Plans and the Cost Estimate are accepted, approved, and ordered filed with the Township Clerk, and the summary thereof attached to this resolution as Exhibit A are hereby approved and made a part of this resolution.
- 3. The Board hereby tentatively declares its intention to construct the Project and tentatively designates the special assessment district named and described in Exhibit B against which the cost of the Project is to be assessed (the "District").
- 4. The Board shall meet at 6:00 p.m., Eastern Standard Time, on Tuesday October 3rd 2023, at the Billings Township Hall, 1050 Estey Road, Road, Beaverton, Michigan, 48612, and during such meeting shall conduct a public hearing to hear objections to the Petition, Project and District as required by Act 188. The form of notice attached hereto as Exhibit C is hereby approved as and for the form of notice for such hearing. The Clerk shall cause notice of such hearing, substantially in the form hereby approved, to be given as follows:
 - a To each record owner of, or party in interest in, land in the District whose name appears on the last Township tax assessment records (as defined below), by first-class mail addressed to such owner or party at such address, at least 10 days before the date of the hearing, provided, however, that if a record owner's name does not appear in the last Township tax assessment records, such notice shall be given by first-class mail addressed to the record owner at the address shown by the records of the Gladwin County Register of Deeds within the time provided in this subparagraph (a);
 - b By publishing such notice twice in the Gladwin County Record, a newspaper of general circulation in the Township, the first such publication to be at least 10 days before the date of the hearing; and
 - c To each person (if any) whose name and address has been filed with the Secretary of State of the State of Michigan as a person upon whom may be served notice of any proceedings under Act 188, by registered mail addressed to such person at such address, or personally, within five days after the first publication of notice pursuant to subparagraph (b) of this paragraph.

As used in subparagraph (a) of this paragraph, the term "last Township tax assessment records" means the last assessment roll for ad valorem tax purposes which was reviewed by the Township Board of Review, as supplemented by any subsequent changes in the names or the addresses of the owners or parties listed on that roll.

- 5. In addition to the notices required by paragraph 4 of this resolution, public notice of the meeting referred to in such paragraph shall be given pursuant to and in full compliance with the Open Meetings Act (Act No. 267, Public Acts of Michigan, 1976, as amended).
- 6. All previous resolutions, or parts of previous resolutions, of the Board that are inconsistent with this resolution are hereby rescinded.

However, appearance and protest at the public hearing on the special assessment roll are required in order to appeal the special assessment to the Michigan Tax Tribunal. The owner or other party in interest or his or her agent may (1) appear in person at the hearing to protest the special assessment, or (2) file his or her appearance or protest by letter before the close of the hearing. The Township Board shall maintain a record of parties who appear to protest at the hearing. If the hearing is terminated or adjourned for the day before a party is provided the opportunity to be heard, a party whose

appearance was recorded shall be considered to have protested the special assessment in person.
